The Captain E.W. Milligan House, now known as Raccoon Lodge, is located at the end of an ell-shaped dirt lane on Raccoon Point. This second quarter of the 19th-century side hall/ parlor frame dwelling stands within ten yards of the Manokin River.

Captain E.W. Milligan is located on the 1877 county atlas as owning 225 acres on Revel's Neck. The close siting of the house to the river suggests Milligan's associations with the water, as does his patron listing occupation as an oysterman and a farmer. He was born in Somerset County around 1820.

The Captain E.W. Milligan House, now known as Raccoon Lodge, is located at the end of an ell-shaped dirt lane on Raccoon Point. The house stands within ten yards of the Manokin River. The house faces west with the primary gable running north/south. Accompanying the house is a small weatherboarded dairy.

The c.1840-1850 two-story two-bay side hall/parlor house is supported by a brick pier foundation and is covered by a medium sloped asphalt tile roof. A uniform sheathing of weatherboards covers the main house as well as the rear service wing. A single-story two-bay hyphen connects a story-and-a-half one-room plan kitchen.

The west elevation is two-bays across with a six-panel door and three-light transom in the south bay. The window sash has been replaced, and a single-story porch covers the first floor. A boxed cornice with a bed molding stretches above the second floor windows.

Each gable end has a single pane sash window on each floor, and the eaves are finished with plain bargeboards.

The two-bay hyphen is simply finished with weatherboards and replaced sash. A shed-roofed porch extends from the north side. A small brick stove stack rises from the east end of the hyphen against the gable end of the kitchen.

The one-room plan kitchen has a gabled dormer on both the north and south roof slopes, while an interior end brick stack rises from the east gable.

The interior has been refurbished as a river-side vacation house, but some period woodwork was retained. The stair remains intact with a medium-sized turned newel post and circular profile handrail. The rest of the house was not seen.

A small weatherboarded dairy with a simple gable roof and wider-than-normal eaves stands southeast of the kitchen. Two small louvered openings flank the center board door. The west side is covered with metal siding, while additions have been attached to the south and east sides.


