The Stephen Maddox house is one of a half-dozen two-story, two-bay frame dwellings that contribute to the historic black community of Upper Hill, Somerset County, Maryland. Estimated to date to the last decades of the nineteenth century, the Stephen Maddox house features six-over-six sash windows and extended eaves with boxed soffits. The side hall/parlor gable roofed main block is extended to the rear by a two-story shed roofed kitchen addition.

Generally referred to as the old Maddox house, the chain of title research for this house and lot document a May 1939 transfer from William H. Adams, a white landowner, to Stephen and Henrietta Maddox for this house and one acre. The house and lot remain under Maddox family ownership. Prior to 1939, the property was held by William H. Adams since 1915, and before him by Edward E. Tull, both of whom probably rented the property to black tenant families. The oldest transfer recorded for the property dates to January 27, 1870, between trustee George W. Covington, and Dr. John Emory Tull.

The Stephen Maddox house is located at 8140 Upper Hill Road in the historic black community of Upper Hill, Somerset County, Maryland. The two-story, two-bay frame house faces east with the gable roof oriented on a north/south axis.

Dating around 1880-1900, this two-story, two-bay side hall/parlor frame house rests on a low brick foundation, and the exterior is clad with a layer of vinyl siding. Attached to the back of the main house is a two-story shed roofed addition.

The east (main) elevation is a two-bay facade with a shed roofed porch sheltering a side entrance filled with a partially glazed front door. The adjacent bay is filled with a six-over-six sash window. Centered on the porch roof is a shallow pitched cross gable. The second floor is lighted by two evenly spaced six-over-six sash windows. Finishing the base of the roof is a boxed cornice, and the soffits are enclosed. An off-center concrete block stove chimney pierces the roofline.

The north and south gable ends are alike with a single six-over-six sash window lighting the first and second floors. The gable end eaves are slightly extended and the soffits are enclosed.

The two-story shed roofed addition extends to the rear and is lighted on the each side by six-over-six sash windows.

The interior was not seen.






