DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This mid 19th century frame house consists of a three bay, two story section with a shorter two story kitchen to the east and a modern two story addition on the west. A two story porch extends across the south side. It is supported by simple square posts and has a balustrade of jig saw cut balusters on the second floor. This side of the roof is pierced by three 6/6 dormers, while there are two dormers, positioned over the end windows, on the north. The house is covered in wooden clapboards.

The floor plan consists of a center hall with a parlor on either side. There is a fireplace for each parlor, one to the east and one to the west. The mantels feature elongated, raised diamond panels. A jig saw cut wave patterned board runs across the face of the mantel under the central panel. The mantel shape is a double ogee with a central bead in plan. The interior architraves are framed with pilasters and topped with a tall, elaborately molded panel. A raised diamond shape ending in arrows is centered in this panel. The stair has an enormous squat, turned newel. It has three straight runs of steps intersected by two landings.

The parlors each have one 6/6 window on either side. The rooms above are similarly fenestrated. The front door has side lights and a transom. Two elongated octagonal panels above a horizontal bar and two shorter octagonal panels embellish the door. There is a door at the north end of the hall, also.

The kitchen addition has one room with an exterior chimney and one room on the west.

STATEMENT OF SIGNIFICANCE

Architecturally, Old Woman's Folly is a typical mid-19th century farm house. The frame structure has a two story porch on its south side which seems to be a frequent occurrence in mid-century Talbot County. Its simplicity is the most important feature of the house. Were it encased in aluminum, it would lose its charm, likewise if the porches were filled, much of the original appeal would be lost.
