DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Ray's Point is located on a lane west of Pea Neck Road, approximately one mile south of Maryland Route 33, south of St. Michaels, Talbot County. The house was constructed in two sections, both of which are representative of different building periods in Talbot County.

The earlier section is the one and one-half story structure which now functions as a service wing to the two story main section of the house. This wing has large sized brick laid in Flemish bond on the south facade and common bond elsewhere. The south facade is presently four bays with a doorway in the third from the west bay. The brickwork, however, shows that several alterations have been made to the fenestration of this facade. The north facade has also been altered to provide for an interior remodeling which has put a modern kitchen in the east room and a study in the west room. The two bay west gable end has a small pyramid chimney, small six-over-six windows on the first story and two-over-two windows on the half-story. There are two gable dormers on the roof.

The main section of the house is two storys, three bays by two bays with interior gable end chimney stacks. The south facade has a double tiered porch with late 19th century trim consisting of square posts with molded capitals on the first story and double pilasters with ornamental trim on the second story. This facade is Flemish bond with a central doorway having a transom and sidelights. There are six-over-six windows in the other bays of the first story, and the second story has French door windows in the outer bays and a small window in the center bay. The east gable end is partially Flemish bond and has six-over-six windows on both storys and four pane casement attic windows. The north facade of the main section has a slightly off center doorway and circular windows have been added to each side of it. Above it is an undersized six-over-six window with full sized six-over-six windows in the outer bays on both storys. This facade is common bond, has a molded box cornice and a Federal style door frame.

The interior of the main section has a central stair hall and a room to each side. The woodwork is simply executed such as the square newel post and thin balusters of the staircase and the serpentine molded door frames.

The property has some old outbuildings including a steep roof clapboard shed with wrought iron hardware and a square brick dairy with an overhanging roof on all sides.

STATEMENT OF SIGNIFICANCE

Ray's Point shows the combination of a representative two story three bay, central hall plan brick house of the early 19th century with a slightly earlier one and one-half story, two room plan brick house. It is a combination that appears frequently in Talbot County domestic architecture and Ray's Point retains the basic relationship between the two sections in use of space and details.
