Recently sandblasted on the facade, the Alsatia Club Building is a typical example of the early nineteenth century Neo-classical influenced urban domestic architecture of western Maryland and south central Pennsylvania. Two and a half stories high with a gable roof and double internal end chimneys, the building is constructed of brick with a side-hall-double-parlor interior arrangement and a three bay, Flemish bonded facade. An interesting feature of the facade (north elevation) is a bow front office extension to the east which was erected about the mid-1890s. Built of brick, the extension does not imitate the design of the original section and looks as though it is a separate structure.

Although the exact date of construction is not known, the basic stylistic and construction features indicate about the early 1820s. It may have been built for Otho Lawrence, an attorney in 1825, who sold a small strip of the land along the east boundary. In the late nineteenth century, the interior was "Victorianized" although, interestingly, the facade was apparently not greatly affected by alterations. The office addition was probably built about 1891 when the property was acquired by J. McPherson Scott, a physician.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The building now occupied by the Alsatia Club stands at 137-141 West Washington Street in Hagerstown, Washington County, and is located on the south side of the street near the center of the block formed by Summit Avenue and Prospect Street, the second block west of Public Square.

The building is a circa 1820s Neoclassical brick urban house, two and a half stories high with a three bay facade, to which a two story, bow front extension was added to the east in the late nineteenth century. Recently sandblasted on the facade and part of the west elevation, the building is a large rectangular, gable roofed structure with interior double-end chimneys and parapets along the end walls. It sits tight to the sidewalk, abutting the neighboring building (Miller House) on the east but free-standing on the west. The street slopes downward easterly resulting with a low brick foundation wall on the east end of the original facade.

As noted above, the facade or north elevation of the original section has three bays with the doorway in the west end bay. The windows have double-hung, wooden sashes with six-over-six lights, narrow frames, wooden sills, and brick flat arches. A small molded cornice runs along under the roof and is terminated on the ends with small Victorian scroll brackets. The doorway has a low arch with sidelights and fluted columns flanking the new door. The arched fan light has curved tracery. The facade bricks are laid in Flemish bond.

The facade of the east extension has a bow front and does not imitate the design of the original facade. The bow has three segmental arch windows with a center door on the first floor. Apparently erected for an office, this extension has a flat roof and a dentiled classical cornice. Three recessed blank brick panels stretch across the bow below the window. A passage to the back of the property stretches along the east side. The windows have rectangular double-hung, wooden sashes with one-over-one lights, inscribed segmental arch panels, narrow frames, and wooden sills. The doorway has a rectangular transom and a wooden door with a large light and two raised panels.

The west wall is blank except for two small attic windows. The bricks are laid in Common bond (five rows of stretchers).

The interior is arranged with a side hall and double parlors corresponding to the fenestration arrangement of the facade. The decorative detailing is late Victorian in influence. The staircase is cantilevered with a round end and rises to the top floor. The balustrade is heavy and rests on the original case.

From 1858 to 1882, the house was owned by Zachariah S. Claggett, a lawyer (Deeds: Book I.N. No. 13, p. 457 and Book 81, p. 669). Claggett represented Washington County in the Maryland State Senate from 1872 to 1874 (Williams, I, 422).


