DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The Warrenfeltz Farm is located west of Edgewood Drive, about 3/4 mile north of Mt. Aetna Road in Washington County, Maryland. It faces south-east.

The structure is a seven-bay stucco covered stone and brick house painted yellow with white and dark green trim. A two-bay roofed wing extends to the rear or northwest of the house.

The method of wall construction is partially concealed by the covering of stucco or "rough cast." The front elevation, however, has been faced with double courses of brick set in common bond.

The windows appear to have been placed evenly in the front and side elevations of the building. However, at the rear walls, openings are placed at random. Windows at the facade contain six-over-six pane double-hung sashes held within narrow frames. Decorative pediments finish the lintels. At the sides and rear of the house, plain wide lintels are present. Louvered shutters flank most windows.

The main entrance is located in the third bay from the southwest end of the house. The doorway is quite elaborate in appearance with a broad transom and sidelights over decorative panels surrounding the door. Victorian period octagonal panels are set below the sidelights and in the jambs. Other entrances are much simpler in appearance and are finished similarly to the windows.

A Victorian period, flat roofed entrance porch with much carved trim is present at the main entrance. It is supported by pairs of square posts below decorative arches. Also at the front elevation is a two-bay recessed porch included under the main roof span and finished with elaborate wood trim.

The roof is covered with slate and extends for several inches beyond the end walls of the house. The eaves at the front elevation are finished with elaborate Victorian period carved brackets. At the rear of the house the boxing is faced with a course of simple molding. Broad brick chimneys rise from inside each gable end.

The interior of the house has massive woodwork and trim. A wide hallway displays a stair with a large newel with turned balusters.

Immediately behind the house is a small log out buildings covered with artificial brick siding. A large stucco covered stone chimney with a brick extension is located at the exterior of the structure. A modern barn is located nearby.

The house is in good condition and stands on a tract containing 104.66 acres.

STATEMENT OF SIGNIFICANCE

The area of significance of this house is its architecture. It is a Victorian period adaptation of the five-bay, center hall plan Georgian form house with an attached recessed double porch. The Georgian form plan and the double porch are significant architectural features of the area with examples dating from the 18th through the 19th centuries.

Local historians report that this house was built ca. 1873 by Martin L. Stockslager, on the site of an earlier log dwelling. It stands on a land grant called "Brother's Request" surveyed for Ignatius Perre, May 1, 1744.



