DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This log cabin is located east of Mt. Lena Road, about one mile north of Mt. Aetna Road in Jugtown, Washington County, Md. It is situated at the foot of the west slope of South Mountain and faces west.

The structure is a one-story, two-bay log dwelling which has been coated with white wash. Lean-to extensions have been attached to the east and west sides of the cabin.

The walls are constructed of squared logs which appear to have been sawn rather than hewn. The present chinking is cement.

The roof is covered with sheet metal. A round stovepipe flue protrudes from the ridge near its center.

The structure which is in deteriorated condition is now used as a storage shed. It stands on a property containing 3.33 acres.

STATEMENT OF SIGNIFICANCE

The area of significance of this house is its architecture. It is a late example of a log dwelling and illustrates the persistence of earlier building traditions. Although the structure does not employ the "U"-notched corner joining usually found in earlier log buildings, it is a cabin quite primitive in appearance for its late 19th century date. Several log structures of this type are in Jugtown.

Otho Brown was known as a "local character" in the Jugtown area. Jugtown apparently got its name from various distilling enterprises in the area.


