DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farm complex is located on the west side of Marsh Pike just north of Paramount in Washington County, Maryland. The house is situated on an area of fairly level ground and faces east.

The dwelling is a two story, three bay brick structure set on low limestone foundations. A two story, four bay ell, also of brick construction extends to the rear or west. A recessed double porch supported by square wooden posts extends along the south elevation of the ell. Its lower level has been enclosed. Bricks forming the walls are laid in American or common bond with generally seven courses of stretchers between header rows. Flat arches of brick are present above the openings.

Windows have narrow frames and are finished with a bead at the inside edge. They have six over six pane double hung sashes. Some windows have hinge pins remaining in their frames indicating that shutters were present at one time. At the first story in the front elevation, two windows are placed side by side divided by a wooden mullion.

The entrance in the front elevation, located in its center bay, is relatively simple and is topped with a single pane transom. A one story porch supported by large wooden posts resting on brick bases extends along the east and south elevations of the front section. In the south gable wall is another entrance, much more elaborate than that in the east elevation. The door is flanked with slender doric-type colonnettes. A broad diamond pane transom and matching side lights complete the entrance. Doors in the ell have six panels and are hung beneath four light transoms.

The roof is covered with sheet metal and extends beyond the end walls. Brick chimneys are located inside each gable end.

Behind the house is a wash house or summer kitchen and other outbuildings. A frame bank barn and other agricultural structures are located west of the house.

The buildings appear to be in good to excellent condition and are located on a tract containing 79.73 acres.

STATEMENT OF SIGNIFICANCE

This farmstead consisting of a brick L-shaped house believed to have been built about 1860, a frame bank barn and various outbuildings provides an example of Washington County's rural building patterns from the mid 19th century. The elaborate entrance with its diamond pane transom and side lights is an unusual type of door treatment among the area's farmhouses.

This farm, part of the "Long Meadows" grant was for many years owned by the Middlekauff family. On October 9, 1846, Daniel Middlekauff sold this farm to Peter Middlekauff, (IN2/108). In January of 1909 Peter Middlekauff's executors sold the farm, then containing 174 1/4 acres and 32 perches to J. Elmer and Leroy K. Lehman. In 1917, it was purchased by S. Leshor Horst who sold it to the present owner in 1939. (130/131, 151/38).


