DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is located on the east side of Maryland route 58, southeast of Cearfoss in Washington County, Maryland. It is situated on an area of level ground and faces southeast.

The structure is a two story, four bay brick building with two doors centered in the front elevation. Bricks are arranged in common bond at all elevations and the entire surface of the building has been painted red. Flat arches of brick are present above windows at the front elevation.

Windows have narrow frames which hold two over two pane double hung sashes. The window frames have hinge pins indicating that shutters were present at one time. Only two windows are located at the second story in the front wall, set toward the corners of the building. The entrances are framed similarly to the windows and include narrow transoms over the doors. A third entrance is located in the southwest end wall. One story shed roofed porches supported by chamfered square posts shelter the doors.

The roof is sheathed with modern asphalt shingles and extends beyond the end walls of the house. Brick chimneys are located inside the end walls.

The house appears to be in good condition.


