DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This small farmstead is located on the west side of Hopewell Road east of the Western Maryland Railroad and south of I-70, northeast of Williamsport in Washington County, Maryland. The house is situated on a slight slope and faces east. It is a two story, three bay wooden dwelling sheathed with composition siding and resting on fieldstone foundations. A one story, two bay wing extends from the south gable end. The dwelling is possibly of log construction, suggested by the thickness of the door and window jambs.

Openings are aligned with each other in the walls and are arranged symmetrically. Two over two pane sashes are used at most windows which are surrounded by plain trim that appear to date from the early 20th century. The main entrance is centered in the front elevation and consists of a door hung beneath a narrow transom and having trim similar to that of the windows. The lintel of the door is at a higher level than those of the two first story windows which could suggest an early building date. Another entrance is located in the front elevation of the one story section.

Both parts of the house are roofed with channel grooved sheet metal. The roof of the main section extends beyond the end walls while that of the wing terminates flush with the wall. Included under the main roof span of the wing is an overhang or porch supported by turned posts with the distance between them spanned by a plain balustrade. A shed roofed porch covers the three openings at the front elevation of the main section. It, too, is supported by turned posts, these having curved brackets at their tops.

A brick chimney which appears to be a replacement of the original is located at the exterior of the south end wall of the main section.

South of the house is a relatively new barn and several wooden sheds and outbuildings. The structures appear to be in fair to good condition. Some distance west of the house at the edge of the railroad tracks is a deteriorated wooden building said to have been a saw mill.

The property, part of the "Resurvey on Salisbury " contains 70.67 acres. It includes the farm complex located on the opposite side of Hopewell Road which is described in survey form WA-I-356.
