DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The William S. Gower and Son feed mill is located at Williamsport Station where the Penn Central Railroad tracks cross Maryland Route 63 just south of Williamsport in Washington County. It is situated on the east side of the road immediately north of the railroad. The building stands on an east-west axis, is of frame construction sheathed with German siding and rests on fieldstone foundations. To its east gable end is attached a newer concrete block extension. Further to the east are other newer buildings for feed and grain storage.

The oldest part of the mill is a two story structure, its sheathing showing no evidence of paint. Openings are aligned with each other at the first and second stories but are spaced at random in the walls. Most windows have six over six pane double hung sashes around which are architraves with pointed top pieces. The building has three openings per story at the north elevation offset toward the west end of the structure. Entrances are located in the second and third bays from the west end. Entrances are also present in the west gable end at the roadside and in the south elevation along the railroad. Overhangs protect the entrances.

The roof is sheathed with slates and extends beyond the end walls. Small brick chimneys with corbels at their tops are located inside the west end south of the roof ridge, and another at the interior of the structure on the roof ridge, west of center.

In addition to the stock feed business a small general store operates from this building.

The structure appears to be in fair to good condition and stands on a tract containing 1.5 acres.
