DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farm complex is located at the end of a private lane, west of Maryland Route 65 and immediately north of I-70, south of Hagerstown in Washington County. The house faces north. It is a two story, five bay log dwelling resting on fieldstone foundations. The surface of the building is sheathed with wooden weatherboarding upon which is a layer of composition siding. A recessed double porch included under the main roof span shelters the west bays of the front or north elevation. One notable feature of the exterior wall surface is the exposed chimney back in the east end wall. This method of chimney construction is found in some log houses and apparently facilitated access to the firebox for repair or replacement.

Many windows, particularly those at the second story retain six over six pane double hung sashes. Others have two over two pane sashes. Two picture windows have been installed in the front elevation at the first story on either side of the door. Window frames are narrow, some with flat applied trim.

The main entrance is located in the second bay from the east end of the house. Other entrances are located in the second bay from the west end at both levels of the double porch.

Extending to the rear of the house is a one story, two bay structure to which is attached rock faced concrete block outkitchen.

Corrugated sheet metal forms the roof of the house which protrudes beyond the end walls. A brick chimney extends from inside the east end wall. It is this chimney that has the exposed fire box back on the exterior wall surface. Smaller brick chimneys are located on the north and south slopes of the roof at the interior of the house, toward its west end.

North of the house is a stone and frame springhouse. Further to the north is a large frame bank barn which faces southeast. Sheds and agricultural structures are located nearby. The property contains approximately 50 acres.




