The brick house is a one story three by two-bay house on a concrete block foundation. It has a gable roof with dormers on the main facade. The brick is laid in stretcher bond.

The property is located on the east side of Rt. 65, .14 mile south of the intersection of I-70. It is located in a group of buildings on $\frac{1}{4}$ to $\frac{1}{2}$ acre lots constructed from mid-20th century to the present time.

The main facade from this house has a central entrance with a white and green striped aluminum awning. Eight-over-one pane windows are located on each side of the central entrance. Gable dormers within six-over-six pane windows are located on the asphalt shingle covered roof. Each gable end contains two windows on the first floor and a small window in the half story. On the southernmost gable end is a concrete block flue projecting from the end of the building.

There are no significant outbuildings on the property.
