DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This house is located near the southeast corner of the intersection of Cool Hollow Road and U.S. Route 40 in Washington County. It is situated on sloping ground above the Beaver Creek and faces northeast.

The structure is a two-story, four-bay brick dwelling with white trim. A two-story, four-bay fieldstone section extends to the rear.

The walls of the brick section are set on high stone foundations which are partially covered with a rough coating of stucco. The bricks of all elevations are laid in common bond with five courses of stretchers between header rows.

Windows in the brick section appear to have been placed with some concern for uniformity. They have narrow framing under wide wooden lintels holding six-over-six light double-hung sashes. Pairs of four-light openings illuminate the attic. One window with wide framing is present in the foundation of the front elevation.

What appears to have been the original main entrance to the brick section is located in the second bay from the east corner of the house. The doorway is treated similarly to the windows and has a four-light transom. Foundations remain of a one-bay entrance porch. A similar entrance is located in the northwest gable side of the house. It is covered with a one-story, one-bay hipped roof entrance porch.

The roof of both sections of the house is covered with sheet metal. The eaves are treated simply with plain boxing under which is a band of molding. The barge boards are set against the house walls. On the stone section, the barge is tapered and finished with a beaded edge.

Brick chimneys rise from inside each gable end.

The stone section of the house is constructed of roughly coursed local limestone. Openings at the first story level have wide framing members with pegged joining. Their inner edges are finished with a bead. Second story windows have narrower framing and do not appear to employ pegged joining. All entrance ways in the stone structure are very plain in design with only one of the three doors having a transom.

Just south of the house is a small stone outbuilding with very low walls. Also present is a large stone end barn. The house is in fair to good condition and stands on a tract containing 219.57 acres.

STATEMENT OF SIGNIFICANCE

The area of significance of this house is its architecture. Built in two sections, it represents different periods of construction. Both parts of the structure are examples of an important architectural group of Washington County and the Cumberland Valley.

Although built separately, both sections employ the four-bay, off-center front door plan. Dwellings with this door and window arrangement are present in great numbers in the Cumberland Valley with most examples dating from the first half of the 19th century.

The stone el, which appears to be the earlier of the two sections is one of several stone dwellings along the Beaver Creek which date from the late 18th and early 19th centuries. A number of these structures are associated with the Newcomer family who came to the Beaver Creek are from Lancaster County, Pa. during the last half of the 18th century. They operated several grain mills along the Beaver Creek, including the "Doub's Mill" (WA-II-090) located a short distance northeast of this house.




