DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This house is located on the south side of Churchey Road about 1/2 mile south of the Porterstown Road in the Sharpsburg vicinity of Washington County, Maryland. It is situated on high ground and faces west.

The structure is a two story, four bay dwelling constructed of hewn logs. V-notched corner joining secures the logs while the spaces between are filled with small, rather evenly cut pieces of wood held with loose mortar and concrete. A log wall running perpendicular to the front and rear elevations at the first story, bisects the house near its center. The form of the house is unusual with its upper story overhanging the main level by several feet at the front elevation. There is no decorative trim associated with the exterior of the structure.

Windows, placed at random, display simple board framing without trim. Entrances appear in the two center bays of the front elevation providing access to each of the two rooms. The entrance treatment is quite plain with narrow board framing similar to that of the window. A third entrance is present in the west elevation.

The roofing material is corrugated sheet metal which terminates with a slender, simply moulded barge board. The eaves are finished with plain boxing at the front elevation while a simple course of moulding serves as trim at the rear or east elevation. Small brick chimneys are located inside each gable end.

The structure is in fair condition and is being refurbished by the present owner. The property contains 3.25 acres. Just across the Churchey Road from this house is a small log bank barn. Under seperate ownership at present, the barn appears to have been associated with this house at one time.

STATEMENT OF SIGNIFICANCE

The area of significance of this house is its architecture. The property on which the house stands derives importance from Antietam Iron Works of which it was a part.

Constructed of log this house is representative of a major architectural group in Washington County and the Cumberland Valley. Log was used extensively as a building material in the area from the earliest days of settlement to well into the nineteenth century. Many of these log structures remain in use today covered with various forms of siding or bricks.

The overhang at the front elevation of this house is unusual. The interior log wall extending through only on the first story suggests that the house may have been built in sections, possibly beginning as a one story structure. The nature of the window and door framing and the type of nogging used between the logs suggests a mid-nineteenth century building date.

The property on which the house stands was purchased by Jacob Domer in 1842 from John McPherson Brien, owner of the Antietam Iron Works. The Iron Works was a thriving industry during the 18th. century. (See form WA-II-031). Shortly after 1800, however, the business began to fail and the several thousand acres of land belonging to the Iron Works was gradually sold. Domer bought 40 acres of Antietam Works situated in the wooded hills east of Sharpsburg for \$10.00. Deeds indicate that he may have built the log structure.


