DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Downsville Church of the Bretheren is located along the Dam # 4 Road about one mile south of Downsville in Washington County, Maryland. It is located on the west side of the road and faces east. The church is a two part brick structure, its older section toward the south being one story high and three bays long. To it was added a five bay modern wing also one story in height.

The original section is constructed in common bond at all elevations and has been painted red.

The building would appear to date from the third quarter of the 19th century or later.


