Based on available information, the Early 19th Century Brick & Stone Farmstead (or Mary L. Shank Property) located on Mansfield Road near Sharpsburg is eligible for the National Register of Historic Places under Criteria A and C, for agriculture, military, and architectural significance. The property is immediately adjacent to and partially within the Antietam National Battlefield. Thus the property was associated with the Civil War events for which the battlefield is significant. In addition, the farmstead and surrounding farmlands contribute to the cultural landscape setting for the battlefield. The farmstead is also significant under Criteria A for agriculture as a representative of Washington County's 19th century agricultural heritage and under Criteria C for architecture as a well-preserved example of a prosperous 19th c. farmstead in Washington County. The property includes an early 19th century brick house, a stone end bank barn and a rich collection of early 2nd quarter outbuildings constructed of a variety of materials. According to SHA, all the outbuildings, as well as the main house and barn contribute to the eligible property.





DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farmstead contains a two story, four bay brick house constructed in Flemish bond at the front elevation. Common bond with five rows of stretchers between header courses is used at the side and rear walls. Windows are relatively small in relation to wall area and the original sashes have been replaced. The front door is located in one of the central bays, off center to the front of the house. Frame and stone domestic outbuildings are present as well as a large stone end bank barn.

STATEMENT OF SIGNIFICANCE

This complex would appear to date from the early part of the second quarter of the 19th century. This is evidenced by the general form and construction of the house. Also present is a complex set of outbuildings which appear contemporary with the house. This farm is located adjacent to the Civil War Battlefield of Antietam and derives further significance from its association with the Battle.


