DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This early 20th century farmhouse is built of brick in all stretcher bond and painted white. Windows have cut stone lintels. The house has an irregular plan with a projecting gable and diagonally cut corners. Decorative corbeling trims the eaves and some corner areas. The roof is hipped and is sheathed with pressed tin shingles. Also present is a frame barn, contemporary with the house with tin shingles like those on the house.
