DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This brick farmhouse, now a main building at the Potomac Fish and Game Club is a two story, four bay structure with Flemish bond at the front elevation. A modern addition is attached to one end of the building. Where original window frames remain, they are wide and hold nine over six sashes at the first story and six over six sashes at the second story level. No other early buildings remain. The house could date from the first quarter of the 19th century.
