This log cabin on the side of Elk Ridge is a one story three bay structure. Its front elevation is partially sheathed with vertical boards. Where logs are exposed, they are hewn and display V-notched corner joining. A brick central chimney does not appear to be original but ruins remain of an earlier stone exterior chimney.


