This farm group includes a two story, four bay L-shaped house with a frame extension. All walls have common bond brick work and are painted red. Windows and doors have wide wood lintels and modern single pane sashes. An early 20th century porch extends across the front and around the side of the house. The building would appear to date from the third quarter of the 19th century.


