The stone house is a two-story stone structure ~~built~~ in a rectangular plan. It is three-bays by two-bays constructed in rough-laid stone with large quions. The main facade has a side entrance plan. The two-over-two sash window is ornamented by round-arch upper panes. The gable roof has a boxed cornice. The structure appears to date from the mid-19th century.

The property is located on the north side of Sandy Hook Road, approximately .06 mile east of Clark Road, in Sandy Hook. The site slopes gently up from the road. The main facade faces south.

The two-story structure is constructed of rough laid stone with large quions. There is a full-length, one-story porch with square posts and panelled railing. The stairs to the porch are located on the west end of the porch. There is a side entrance with small transom. Late 19th century window sash is on the main facade containing two-over-two sash with round-arch upper sash. In the two bays on each story of the gable ends are six-over-six sash windows. The gable roof has a boxed cornice. A brick chimney rises interior-end from the east gable end.
