The frame house is a two-story structure constructed in a rectangular plan. It is three-bays by two-bays with a gable roof. The main facade has a one-story porch that wraps around the east side of the house. The structure is constructed in a slope so that the foundation level is a full story on the main facade. The structure has a side entrance plan. Main ornamental features are brackets and spindle railing of the porch. The structure appears to date from the late 19th century.

The property is located on the north side of Sandy Hook Road, approximately .04 mile west of Clark Road, in Sandy Hook. The house sits slightly back from the road. The main facade faces south.

The two-story structure is constructed of frame and covered in a modern asbestos siding. The main facade is asymmetrically arranged with a side entrance plan and a porch that wraps around the east facade. The entrance is located in the westernmost bay on the first story. Two-over-two sash windows are located in the other bays of the first floor and the three bays of the second story. The porch is supported on a stone foundation and covered in lattice-work. The shed porch is supported by square posts. It has ornamental brackets and a spindle railing. A long flight of stairs rises from the east side of the porch at the location where the porch wraps around the east facade. The structure has a gable roof covered in asphalt shingles. An interior-end brick chimney stack rises from the east gable end.
