DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The buildings on Cedar Brook Farm include a stone and frame house, a log smoke house, frame bank barn with brick graineries and related agricultural outbuildings. They are situated near Rockdale Run. On the creek once stood a tannery which operated during the 19th century. Artifacts from the tannery have been found in the bed of Rockdale Run west of the house when it changed course slightly. Among these relics were wooden tubs or vats, about 6' X 8' X 8" with plank bottoms. Some of these vats held bark inside.

The house is a two story, three bay stone structure built of roughly coursed local limestone. First and ground story openings are topped with flat arches of angle cut stones. High in the west gable is an arched tablet trimmed with bricks. Apparently it was designed to carry a date but it holds no such information now. In the east end is a round tablet also lined with bricks. All first and second story window frames have been replaced and single pane double hung sashes have been installed. Large wide frames do remain at attic level windows, however.

A side front entrance opens into a stair hall. Interior doors have six raised panels and one door in the parlor has long strap hinges. Window and door architraves are trimmed with cove molding. The three bay frame wing is an addition. Its northernmost room rests on old foundations which enclose a spring.

STATEMENT OF SIGNIFICANCE

This complex probably dates from the early 19th century. The house shows evidence at its exterior and interior of construction during the 1800-1815 period. The old foundations housing the spring may predate the stone section and may have been part of an earlier dwelling. The property is significant for its architecture as an example of period construction and for its association with an early local industry, the tannery.

The property was owned through much of the 19th century and into the 20th by generations of the Troup family. Adam and Samuel Troup purchased the farm in a series of transactions between 1799 and 1831 from John Snavely (Schnebly), John Bowles and Joseph Fiery. Presumably Adam and Samuel Troup established the tannery and built the stone house. The land is part of the grants "Bowles Establishment" and "Three Friends."


