Crown Stone Farm, located on the Mason-Dixon Line is improved with a two story log house with a two bay, one story addition, a stone springhouse and a frame bank barn with brick graineries.

The house is a two story, four bay structure sheathed with asbestos shingle siding. It has two doors placed side by side in the center of the front elevation. Windows have six over six pane sashes with wide frames.

A small springhouse with a finished upper story is located southwest of the house.

STATEMENT OF SIGNIFICANCE

This is a typical early 19th century farmstead. It has been in the family of the present owner since 1845. The one story addition dates from Ca. 1860 and the main part of the house is said to have been standing at the time the Schnebley family took possession. The farm lies on both sides of the Mason-Dixon Line with a crownstone (five mile) marker within its bounds.


