DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This early 20th century commercial style building is situated on the west side of North Conococheague Street, facing east. It is a two story structure built of tan brick. Its first story would appear to have been altered in the mid 20th century, but the upper portion of the building is essentially intact. Fenestration at the second story consists of three adjoining sets of paired multi-paned windows beneath a molded projection. On either side of the bank of windows are flat pilasters with stylized capitals supporting a cornice which extends across the entire front of the building.


