Situated on a large lot on the north side of East Potomac Street and facing south is a large two story, three bay, neo-Colonial residence. It has a slate covered hip roof with dormers, a projecting pedimented two story central porch with a continuing one story wrap around porch across the front and sides. The symmetrical facade is accented by the large front door with transom and sidelights. This house was built ca. 1900.


