DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Situated on the northeast corner of West Salisbury Street and Vermont Street facing south is a two story, attic and basement, five bay brick house with a two story shed roof, frame, three bay infill addition to the east. The brick section has a slate roof, two over two double hung sash with wide wooden lintels over the openings, large brackets and a frieze board under the eaves. This section was built in the last quarter of the 19th century.

The frame addition has composition brick shingle siding, one over one windows and was built in the early 20th century.


