DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Situated on the north side of West Salisbury Street facing south is a two story, asymmetrical frame house. A central projecting cross gable extends to the front. It has a composition shingle roof asbestos siding, flat top architraves surrounding one over one double hung sash. A one story porch surrounds the projecting cross gable. This building was constructed in the early 20th century.


