Situated on the north side of East Salisbury Street facing south is a two story with attic, asymmetrical frame house. It has a slate roof, asbestos siding, an off center cross gable, flat top architraves surrounding a decorative single pane over a plain one light sash. A porch with a hip roof extends across the front. This building was constructed in the early 20th century.
