DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Situated on the north side of East Church Street facing south is a brick church built in 1845. The western portion of the building which is the sanctuary presents a gable to the road. Centered in this gable is a brick bell tower with a frame bell chamber and roof. To the eastern half of the building a set back smaller cross gable enters to the Sunday School areas. The gable has a round arch window and all the other openings have round arch brick header openings. The brick work is set into a Flemish bond pattern.


