DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house located on the south side of West Potomac Street is a two story, three bay brick structure facing north. Its walls have been painted white. Flat arches of brick are present above the openings. Windows have two over two or single pane double hung sashes. The main entrance is located in the central bay and includes a transom. The roof is covered with standing seam sheet metal. A brick chimney is located inside the east end wall. The house would appear to date from the mid 19th century.


