DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house, located on the west side of North Vermont Street is a two story, four bay log structure covered with composition siding. It probably dates from the late 18th or very early 19th century. Windows have two over two panes which are not original. The off center entrance is located in the second bay from the north end. Brick chimneys are located inside the end walls. There is a shed roofed addition to the rear. The house appears to be in good condition.


