DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house, located on the south side of West Salisbury Street, is a two story, three bay brick structure with a projecting gable at its front. The house would appear to date from the early 20th century. Bricks are laid in common bond and segmental arches are present above the openings. Windows have single pane double hung sashes with most front windows being paired and separated by wide wood mullions. The main entrance is located in the center of the house, at the west end of the projecting section. The door has a large oval glass pane
