DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house, located on the south side of East Church Street is a two story, five bay log building probably dating from the late 18th century. The walls are covered with asbestos shingle siding. Windows have wide wooden frames with six over nine light sash at both the first and second story levels. The main entrance is located in the center bay of the front elevation. A secondary entrance is located in the westernmost bay. The roof is covered with standing seam sheet metal. Brick chimneys are located inside the end walls. A small one story, two bay extension is attached to the west gable end.
