DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house located on the south side of West Church Street is a two story, four bay balloon frame building dating from the early 20th century. It has been covered with aluminum siding. Windows have single pane sashes and several have been grouped into pairs separated by wood mullions. Small brick chimneys with corbels at their tops are located at the east gable end and at the interior of the house. The roofing material is standing seam sheet metal.
