Situated on the east side of North Artizan Street facing west is a three bay, one and one half story brick house built in the 1920's in the bungalow style. Roofed with composition shingle, the windows are slightly arched with one over one sash. One dormer protrudes from the roof that extends beyond the front wall to form the porch.


