DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is located on a narrow lot on the west side of S. Artizan Street. It is a two story, two bay structure covered with aluminum siding. Windows have single pane double hung sashes. Windows in the south bay at the first and second story are double. The main entrance is in the north bay and includes a transom. A small brick chimney with corbels at its top extends from the center of the building. It would appear to date from the early 20th century.
