DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is located on the south side of East Frederick Street. It is a two story frame structure dating from the early 20th century and exhibiting influence of the Queen Anne Style. It is of irregular shape and covered with German siding. It also has decorative shingle trim. It is a three bay structure with a semi-hexagonal projection at the front having a pedimented cross gable at its top with a pallasian window and brackets. The main entrance is in a separate projecting square tower with a hipped roof. Windows have single pane double hung sashes. Those at the front are large with small square decorative panes along their sides. The porch across the front has tuscan doric pillars and a pediment with curved trim over the entrance. The house is in good condition.
