Dated by a stamped brick to 1879, the Gingerbread house is an important St. Michaels building for several reasons. First, it is one of the few nineteenth-century structures with a confirmed date of construction, and secondly, it is one of the best preserved Victorian exteriors with its elaborate decorative trim, two-story porch, and arched sash windows flanked by corresponding shutters. The irregular T-plan houses were popularly built during the mid to late nineteenth century, and St. Michaels builders appear to have developed their own affinity for two-story porches on the front, side, or rear elevations. The history of this house is tied to the lots on the north and south sides. The single-story shop to the north, now used as an ice cream parlor (T-558), carries the same decorative roof trim as the house.

Gingerbread House description

The Gingerbread House stands at 103 Talbot Street at the north end of the center business district in St. Michaels, Talbot County, Maryland. The two-story tee-shaped frame house faces west.

Dated by a stamped brick to 1879, the Gingerbread house is supported by a minimal brick foundation and is sheathed by a uniform layer of novelty siding. The medium pitched asphalt shingle roof is trimmed on the front and north end with decorative sawn bargeboards and fascia.

The west (main) elevation is an asymmetrical four-bay facade. The tee-plan provides a bold gable-front elevation, a recessed entrance, and corner space for a two-story porch covering the entrance. The gable-front (south) bay is distinguished on the first floor with a projecting bay window covered by a bracketed roof. The bay is pierced on three sides by arched single-pane sash windows with the west face having a pair of arched sash. The second floor is also marked by identical paired sash flanked by correspondingly arched shutters. The extended eave is finished with a pierced bargeboard. Interior brick chimneys rise from the center of the tee-plan as well as from the north and east gable ends. The datebrick is located in the southwest corner of the foundation and also carries the name "Watkins." The west elevation of the entrance facade is fully covered by a two-story shed-roofed porch supported by chamfered posts and trimmed with the same pierced sawnwork. Stretching between each porch post is a sawn baluster railing. Fixed between the first floor porch posts (hidden by the cloth awning) are two panels of "Eastlake" spindle decoration. The field of vertical spindles are interrupted with sunburst of cross patterns. The front door is located in the south bay of the recessed elevation. An oval window of beveled glass accompanied by applied floral ornament distinguishes the front door. The front door is flanked by two-light sidelights and a three-light transom. The adjacent first floor windows are four over four sash which are repeated on the second floor. Access to the second floor porch is gained through a four-panel door topped by a two-light transom that is located directly above the front door.

The north gable end has a single four over four sash window on each floor that pierce the wall to the left of the interior end brick chimney. The south wall is evenly divided into two bays also marked by four over four sash windows. Later openings have been cut in for an air conditioner.

Extending from the back of the house is a shorter two-story service wing with an interior end brick chimney.

The interior has been modified through the years with the replacement of the Victorian mantels. The stair is located in the center of the house and rises in an ell-shape. The large square newel post has flat paneled sides, while square balusters support a molded handrail. The north room retains a small closet to the left of the stove stack. The southern two rooms have early twentieth-century brick hearths. The second floor is divided in a similar manner to the first floor. Shallow four-panel doors are framed by late nineteenth-century molded surrounds. Bracketed mantel shelves remain intact in the second floor bedrooms.




