Based on the available information, Mewshaw's Store does not appear to meet the National Register Criteria for individual listing. The commercial building at the intersection of Crain Highway and Greenway Avenue in Glen Burnie probably dates to the late 1890s. However the two-story, side-gable historic core is today largely obscured with later shop front additions and an elongated two-story rear addition. According to local histories, Frank Mewshaw opened Glen Burnie's first store here in 1896 and operated it until 1940. Sometime in the 1920s, a one-story storefront was added to the front. Numerous other alterations have followed. The building does not retain sufficient integrity to convey its history as Glen Burnie's earliest store. It is separated from the National Register eligible Glen Burnie Historic District by Greenway Avenue and is not located in an area likely to constitute an eligible district.

Contributing Resource Count: 1 building.

This commercial building on the north corner of the intersection of Crain Highway and Greenway Avenue consists of a two-story, side-gable-roofed, historic core with modern shop front additions and elongated two-story gabled rear additions. The seven-bay building has a door in its first bay that leads to office space. The remaining bays contain shop front windows and entries. The first-story of the front elevation is clad with brick veneer, and the upper story is clad in synthetic siding and is punctuated with two gabled dormers. The gable end visible on the southwest side is clad in formstone. The one-over-one windows throughout appear to be replacements.

According to local histories of Glen Burnie, Frank Mewshaw opened Glen Burnie's first store on this corner in 1896 and operated the business until around 1940. Sanborn maps from 1922 and 1931 indicate that the two-story building was freestanding at the time with a detached dwelling as its neighbor to the north. Sometime during the 1920s, a one-story store front was added on the front, which is shown on the 1931 Sanborn map and in a photograph of the building taken in the 1920s. This photograph shows the frame building with two-over-two double-hung sash windows on the upper story and bands of four-light fixed windows on the lower story. By this time, its front was already cluttered with signs. City directories indicate that the store was occupied by a toy and sport shop in the 1950s and by a paint store in the 1960s. Presently, part of the building is occupied by a pawn shop and the other by a hair salon.


