Naval Radio Transmitter Facility  
Building NA54, located at the ~~Naval Air Station~~ in the North Severn area of the US Naval Academy in Anne Arundel County, is not located within the boundaries of a National Register-eligible historic district, nor is it considered eligible for individual listing on the National Register of Historic Places.

Built in 1933, Building NA54 was constructed as a single-car garage for Quarters A (Building NA12). The building is a one-bay frame structure covered with a gable roof and featuring a single garage door opening on center in the gable-end facade.

The Naval Radio Transmitter Facility was established in 1918 on land which was prior to that used by the Navy as the Naval Aviation Camp, Greenbury Point, and prior to that as the Naval Academy Dairy Farm. The Radio Transmitter Facility provides low-frequency communications support to the Navy's fleet, including strategic and tactical submarines patrolling the Atlantic Ocean and to NATO forces, and Defense Communications Agency.

Building NA54, was built as a garage for Building NA12 and lacks the architectural or historical significance necessary to be considered for listing on the Register.

**DESCRIPTION**



Built in 1918 according to Naval Academy North Severn documents, Quarters B (Building NA12) stands approximately 50 meters (150 feet) east of Hooper High Road's intersection with Bullard Boulevard near Possum Point in Anne Arundel County, Maryland. Roughly forming an overall ell plan, the one-story frame dwelling with asphalt-shingled gable roofs, vinyl siding and brick foundations (Photo 41500-14) sits adjacent to grass lawns, a tennis court, a frame garage (Building NA54) and a circular gravel driveway. Portions of the vinyl siding have been removed revealing earlier wooden german siding underneath. A modern wooden deck has been appended to the southeast side of the house (Photo 41500-12).


Building NA12 exhibits at least two periods of construction. Probably originally built as an ell three bays wide along its north elevation and five or more bays deep on its western elevation facing the gravel driveway, later construction added a wing to the southwestern portion of the building that enclosed one or more bays of the original west elevation. A noticeable seam separating the two sections survives in the brick foundations. Subsequent infill of the southeastern elbow of the ell with a shed-roofed addition, as well as the enclosure of a porch along the southwest gable end (Photo 41500-13), has created the present ell-shaped footprint. A one-story, shed-roof porch protects a west elevation entrance. A small aluminum entry hood protects an door located in the north elevation of the southwest wing. Aluminized cornices and partial returns ornament the dwelling. Two exterior, metal chimney flues extend skywards along the southern gable end.

Most fenestral openings contain wooden windows with plastic muntins imitating eight-over-eight sash. A few openings possess plastic muntins for six-over-six sash. Semicircular louvers penetrate the gable peaks of the house. A three-panel door with six lights protected by the west elevation's porch allows access into the house. A second entry, shielded by the aluminum entry hood, contains a six-panel door.

An associated garage, Building NA54, stands immediately southwest of Quarters B (Photo 41500-15). One-story tall of frame construction atop a poured concrete foundation, the garage provides shelter for one vehicle through the vertically-rolling wooden garage door located in its western elevation. Two six-light wooden casement windows penetrate both the south and north elevations (Photo 41500-16). A similar window lights the east elevation of the vinyl-sided garage. Asphalt-shingles encase the gable roof.
