

## **CAPSULE SUMMARY**

**Naylor Store and Barn  
Vincent Road  
BA-2842**

The Naylor family, who had originally purchased the undeveloped parcel in 1934, constructed the store and the barn between 1947 and 1952. The Naylor family retained ownership of the Commercial site until 1963, conveying it to present owner Webster Baker. The buildings are examples of Colonial Revival style as practiced in the mid-twentieth century, representing the Commercial growth in a rural crossroads community.

The Naylor Store and Barn are located at the west corner of Bird River and Vincent roads. The lot is very overgrown, with a gravel parking lot in front and a tall wood and chain link fence at the rear.

The 1-1/2-story wood frame antique store is set close to the road, and the 1-1/2-story concrete block barn is located to the northwest of the store. Both buildings are Colonial Revival in design with gambrel roofs. A one-story, wood frame addition has been wrapped around the north and west elevations of the antique store.

The barn and antique store were constructed at the west corner of Bird River and Vincent roads between 1947 and 1952. The lot is very overgrown, with a gravel parking lot in front and a tall wood and chain link fence at the rear. The 1-1/2-story, wood frame antique store is set close to the road, and the 1-1/2-story, concrete block barn is located to the northwest of the store. Both buildings are Colonial Revival in design with gambrel roofs. A one-story, wood frame addition has been wrapped around the north and west elevations of the antique store.

**EXTERIOR DESCRIPTION:**

The antique store, 1-1/2 stories in height, is three bays wide. Clad in synthetic cast stone, the building is covered with a butterfly gambrel roof. The first story of the east elevation, the facade, has a central entry that is filled with a single-leaf, flush door. To either side of the door is a fixed window of glass block. At the second story, each of the three bays is marked with a gable roof dormer with a 1/1 window.

The original first story of the north elevation of the antique store is completely obscured by a one-story, wood frame addition with a shed roof. At the west end of this elevation is a single-leaf, flush door. The original second story wall, however, remains visible. The second story is four bays wide, with two bays, each expressed with a 1/1 window, in each gambrel end.

The one-story shed roof addition wraps around the north end of the west elevation. To the south of the addition at the first story is a single-leaf, flush door. Also at the first story is a 1/1 window. The second story is pierced at the south two bays by gable roof dormers filled with 1/1 windows.

The south elevation is almost completely obscured by overgrown vegetation. It is likely to be identical at the second story to the north elevation. Part of a 1/1 window can be seen in the easternmost bay of the second story at this elevation.

**OUTBUILDINGS:**

The east elevation, the facade of the 1-1/2-story barn, is two bays in width. The first story is concrete block, and the gambrel roof ends are clad in asbestos shingles. The original first story has been significantly altered, and the original barn door has been replaced with a garage door. A multi-light window has also been fashioned in a makeshift manner at this elevation. The two bays of the second story are articulated with two windows, one a 6/6 aluminum window, and one a 1-light fixed, aluminum window. Aluminum cladding surrounds the openings.

The south elevation does not contain any openings, and the gambrel roof extends down to the first story. The west elevation is pierced only at the second story with a single-leaf, two-light door and a 1/1 window. Like the south elevation, the north elevation does not contain any openings.

Directly west of the store and south of the barn is a small wood frame shed. The shed roof is covered with corrugated metal sheeting

National Register Evaluation:

The Naylor Store and Barn at the 100 Block of Vincent Road are not eligible due to the fact that they do not meet National Register Criteria A, B, C, or D. Preliminary research has not revealed any association between the buildings and events that have made a significant contribution to the broad patterns of our history (Criterion A) or the lives of persons significant in our past (Criterion B). Although the buildings provide examples of the Colonial Revival style, they are neither unusual nor distinguished; they do not represent the work of a master or display high artistic merit (Criterion C). There is no evidence that the property is likely to yield information important in history or prehistory (Criterion D). Thus, the property is not National Register-eligible.




