This one and a half story building rests on a concrete pad foundation, is sheathed with aluminum siding and has a slightly pitched gable roof. It has three service bays for automobiles and a separate section of two bays for office space. The office facade is made of brick and is only one story high. The door is made of wood and glass above which is a sign that is situated in a 45 degree angle from the facade and is double sided. There are two sets each of the three wooden and glass overhead garage doors at the front and rear elevations.
