Description: The Enoch and Lydia Jones Farm, located on the south side of Burnt Store Road in the Hughesville vicinity, Charles County, consists of a circa 1880, 2½-story, 3-bay I-house and garage, ten barns, seven sheds, and three tenant house complexes. The wood-frame I-house has a brick foundation, asbestos siding, and an asphalt shingle, side-gable roof with a center gable on the front (north) elevation. The structure comprises the main block, a 2-story rear ell, a 1½-story rear addition which projects to the south from the rear ell, and a 1-story enclosed porch which projects to the south from the 1½-story rear addition. The 119.7 hectares (296 acres) associated with the farm is still in agricultural use and all of the barns are used as part of the active farm. The main house and the second and third tenant houses remain occupied; the first tenant house is currently vacant.

Significance: The Maryland Historical Trust determined on August 29, 1997 that the Jones Farm, which includes the main house and garage, ten barns, seven sheds and three tenant house complexes, is not eligible for the National Register of Historic Places. The property is not eligible under Criterion A, as research conducted indicates no association with any historic events or trends significant in the development of national, state or local history. Historic research indicates that the property has no association with persons who have made specific contributions to history, and therefore, it does not meet Criterion B. Although this is an intact working farm, the house and outbuildings do not compare with other National Register-eligible buildings in Charles County, and therefore, the Trust determined that the property is not eligible under Criterion C. Finally, the structure has no known potential to yield important information, and therefore, is not eligible under Criterion D.

The Enoch and Lydia Jones Farm, located on the south side of Burnt Store Road in the Hughesville vicinity, Charles County, is composed of a circa 1880 2½-story, 3-bay I-house and garage, ten barns, seven sheds, and three tenant house complexes. The wood-frame I-house has a brick foundation, asbestos siding, and an asphalt shingle, side-gable roof with a center gable on the front (north) elevation. The structure comprises the main block, a 2-story rear ell, a 1½-story rear addition which projects to the south from the rear ell, and a 1-story enclosed porch which projects to the south from the 1½-story rear addition. There are three, brick chimneys in the structure; one in the main block, one in the rear ell, and one in the 1½-story rear addition.

The north, or front elevation has a 1-story, full-width, hipped roof porch which wraps around to the east elevation. The porch has wood posts and wood-frame screens. Centered on the elevation is a door with a 2-light transom and 5-light side-lights. Located on each side of the entry is one, 6/6 double-hung, wood window.

The first story of the east elevation of the main block and the rear ell are covered by the 1-story porch which wraps around from the front elevation. The main block has two, 6/6 double-hung, wood windows on both the first and second stories. The first story of the rear ell has one door and one, 6/6 double-hung, wood window. The second story of the ell has one, 6/6 double-hung, wood window. The east elevation of the 1½-story rear addition has one, 6/6 double-hung, wood window on the first story, and the enclosed porch has paired 8/8 double-hung, wood windows.

The south, or rear elevation of the main block has one, 6/6 double-hung, wood window on both the first and second stories. The rear ell has one, 4/4 double-hung, wood window in the gable end. The 1½-story rear addition has no fenestration and the enclosed porch has three, 8/8 double-hung, wood windows, a door, and two, 6/6 double-hung, wood windows.

The west elevation of the main block has two, 6/6 double-hung, wood windows on both the first and second stories. The rear ell has two, 6/6 double-hung, wood windows on the first story and one, 6/6 double-hung, wood windows on the second story. The 1½-story rear addition has one, 6/6 double-hung, wood window on the first story and the enclosed porch has two, 8/8 double-hung, wood windows.

Interior access to the house was unavailable.

The first outbuilding is a 1-story, front-gable garage located southeast of the house. It has a metal roof, board-and-batten siding and no foundation.

There are seven sheds associated with the Jones Farm. The first two sheds are wood-frame, 1-story, front-gable structures with metal roofs and vertical wood siding. Both sheds are located south of the I-house.

The third shed is a wood-frame, 1-story structure with a side-gable, metal roof. It has vertical wood siding and is located southeast of the house and the first two sheds.

The fourth shed is a 1-story, wood-frame structure with a front-gable, metal roof. It has wood clapboard siding and is located at the southwest corner of the house.

The fifth shed is a wood-frame, 1-story structure with a metal, shed roof. Located southwest of the house and south of the fourth shed, it is clad in vertical wood siding.

The sixth and seventh sheds are 1-story, wood-frame structures located southwest of the house and west of the fourth and fifth sheds. They both have metal, side-gable roofs, wood clapboard siding and brick chimneys.

In addition to the sheds, there are ten barns associated with the farm. The first barn is a small structure located south of the house. This 2-story, wood-frame structure has a 1-story shed roof extension which projects to the west. It has a metal roof and is clad in vertical wood siding.

The second barn is a 2-story structure with a side-gable metal roof. It has a brick foundation and vertical wood siding and is located southeast of the house and northeast of the first barn.

The third, fourth, fifth and sixth barns are tobacco barns which form a complex located approximately .4 kilometers (.25 miles) southwest of the house and sheds and the first two barns. The third barn is a 2½-story, front-gable structure. The structure is clad in vertical wood siding and has a metal roof.

The fourth barn is also a 2½-story, front-gable tobacco barn. It has vertical wood siding and a metal roof, and the first story of the south elevation has open bays. The barn is located southeast of the third barn.

The fifth barn, a 2½-story tobacco barn, has a front-gable metal roof and vertical wood siding. A 1-story tobacco stripping room with a brick chimney projects from the north elevation of the barn. The structure is located south of the third barn and southwest of the fourth barn.

The sixth barn is a 2½-story structure with a front-gable, metal roof and vertical wood siding. This tobacco barn is located south of the third and fifth barns and southwest of the fourth barn.

The seventh and eighth barns are located approximately .8 kilometers (.5 miles) southwest of the house and sheds, and approximately .4 kilometers (.25 miles) west of the complex of four tobacco barns. Both structures are 2½-story tobacco barns with front-gable metal roofs and vertical wood siding.

The ninth barn, which is located approximately .4 kilometers (.25 miles) east of the house and is now on a separate parcel. This 2½-story tobacco barn has a side-gable, metal roof and vertical wood siding.

The tenth barn, which is now on a separate parcel from the house and on the same parcel as the ninth barn, is located approximately .4 kilometers (.25 miles) northeast of the house and north of the ninth barn. It is also a 2½-story tobacco barn with a side-gable, metal roof and vertical wood siding.

The final component of the farm is three tenant house complexes. The first complex includes a circa 1910, front-gable cottage and a shed, located approximately .4 kilometers (.25 miles) southwest of the main house and east of the four-barn complex. The 1½-story, 3-bay cottage has a concrete foundation, wood clapboard siding and an asphalt shingle roof with exposed rafter ends. It has 6/6 double-hung, wood windows and a central brick chimney. A 1-story, hipped roof porch is located on the front (north) elevation. A 1-story, front-gable shed is located south of the cottage. It has a metal roof and vertical wood siding.

The second tenant house complex is located 1.2 kilometers (.75 miles) east of the main house. The complex comprises a circa 1910, 2½-story, 3-bay I-house, two barns, and four sheds. The wood-frame I-house has a concrete foundation, wood clapboard siding and a metal, side-gable roof with a central brick chimney. A 1-story, full-width, shed roof porch is located on the front (east) elevation and the structure has 2/2 double-hung, wood windows. A 2-story, shed roof addition projects from the rear (west) elevation and is clad with asphalt shingles. The two barns associated with this complex are 2-story side-gable structures with vertical wood siding and are located southwest of the house. Four, 1-story, wood-frame sheds are located south of the house and northwest of the barns. Three are gable-roof structures, one has a shed roof and all have vertical wood siding.

The third tenant house is located approximately 1.2 kilometers (.75 miles) east of the main house and east of the second tenant house complex, adjacent to Gilbert Creek. The structure is a 1½-story, 3-bay, front-gable cottage. The circa 1910, wood-frame structure has a concrete foundation, wood clapboard siding and a metal roof. Wood-frame, 1/1 double-hung, windows are located throughout the structure and it has a central brick chimney.

The Jones Farm is located south of Burnt Store Road and retains 119.7 hectares (296 acres). The land is still in agricultural use and all of the barns are used as part of the active farm. The main house and the second and third tenant houses remain occupied; the first tenant house is currently vacant.

Maryland and the District of Columbia called Hughesville a "post town." Bland's 1887 Maryland Directory and State Gazetteer listed both Episcopal and Roman Catholic churches in Hughesville as well as a Friends' school, four (4) general merchandise stores, two (2) saloons, two (2) undertakers, a wheelwright, a blacksmith, a tobacco buyer, and a population of fifty (50). Gannett's 1904 Gazetteer of Maryland defined Hughesville as a "post village...on the Washington, Potomac and Chesapeake Railroad" (Gannett 1904: 43). By 1906 the community was known as "a station of the Southern Maryland Railroad...and a banking town" with two (2) physicians, two (2) general stores, two (2) blacksmiths, a grist and saw mill, a flour mill, an undertaker and livery, a hotel, a hotel and saloon, a grocer and saloon, an insurance salesman, and a population of 150 (Maryland 1906: 667).

The main house and the second tenant house on the Jones Farm are I-houses. The standard I-house is one room deep and two stories tall with three to five openings on each story. From the front, an I-house is often indistinguishable from a Georgian house. The gable view, however, reveals the greater depth of the Georgian house. Chimneys are most often located on the interior of the gable ends, however, some I-houses can have central, interior end or exterior end chimneys. Usually, an I-house has a 1-story porch running the length or nearly the length of the long side. On the interior, a central hall separates the two rooms on the first floor; the second floor contains either two or four sleeping chambers. Due to the narrowness of the main core, many I-houses have kitchen wings to the rear. During the Victorian period, pre-cut detailing or a 2-tiered porch was commonly grafted onto the traditional I-house. The I-form was popular into the early twentieth century, with examples appearing in catalogs of mass-produced suburban houses (Gowans 1992, 55-6).

The first and third tenant houses on the Jones Farm are front-gable cottages. Between 1870 and 1940 the vernacular cottage style was typically built for Americans of modest means. They are characterized by simple ornamentation and mass-produced components, such as door frames, moldings, sash and window units, and porch decoration. The development of post-Civil War machinery capable of producing large amounts of standardized housing elements, such as those found in cottages, contributed greatly to the development of the modern American housing industry. Designs for vernacular cottages were obtained from popular magazines, such as House Beautiful, or carpenter's and builder's journals, such as American Builder. A variety of front-gable, side-gable, cross-gable and hipped roof frame cottages were developed in the early to mid-twentieth century. Front-gable and hipped roof cottages are primarily 1 to 1½-stories tall, 3-bays wide and several rooms deep. Side-gable and cross-gable structures are usually 2 to 2½-stories tall, are typically 2 to 3-bays in width and vary from one to three rooms deep. They usually include a porch covered with a shed roof. Porches are supported by posts often containing machine-produced Victorian ornamentation. Some cottages feature ornamentation drawn from Craftsman style or Colonial Revival architecture (Gottfried and Jennings 1988, viii-xv).

Most inhabitants of the project area were engaged in farming at the time of first settlement and the Jones Farm includes ten barns. The barn was the principal building erected on a farm which provided space for cows, horses, equipment, and hay, straw or tobacco storage. Throughout the nineteenth century, barns increased in size or were newly built to include space for smaller

animals, such as poultry and pigs, and as a place for the threshing and storage of grain. Their size also increased during the nineteenth century as the introduction of improved equipment led to more efficient and profitable operations, and, consequently, to increased need for storage facilities (Grow 1985, 60 and 76). Typically, livestock was housed on the lower level, while the upper level was reserved for the storage of hay and straw, and the threshing and storage of feed grains.

The production of tobacco created the need for a barn designed for the special storage and "curing" of the crop. The structures were long, wooden buildings with a gable roof. The interior had a central aisle and was divided into compartments by a network of wooden beams and "tie-poles." From these beams the tobacco was hung and allowed to naturally air-dry. To facilitate the curing process, the barns were designed with several methods of ventilation. Many barns had windows or ventilators near the roof ridge, while others had vertical board siding which were hinged for vent openings or loosely spaced. Another common feature was the elevation of the barn on "legs" which provided air circulation from below the barn (Caravan 1995, 37). The Jones Farm includes eight tobacco barns.

National Register Evaluation:




