Although this appears to be a simple early 20th century frame house, an extant photograph shows the building's original appearance as a one-room, one-story cottage with a rear shed addition. Later another section was added to the south, and finally all three parts were raised to two full stories early in this century. The original rear addition sits over a stone cellar. The late 19th century photograph shows an exterior chimney and a single dormer. A picket fence surrounds the house, whose front porch shelters five people with their dog. An enormous contraption supporting a set of swings takes up most of the porch.

The late 19th century photograph shows an exterior chimney and a single dormer. A picket fence surrounds the house, whose front porch shelters six people with their dog. An enormous contraption supporting a set of swings takes up most of the porch.

The original house was heated by a large exterior chimney at the north gable end. On the front elevation, a door occupied the north bay while a 9/6 sash window lit the south bay. This house comprised the north parlor and the stair hall of the present house. The south addition's interior chimney at the south end, visible in the attic, retains metal flashing for the gable of a 1 or 1½ story house.

In its present form, the three-bay-long house with a central door is covered with asbestos shingles and roofed with asphalt shingles. The central cross-gable is lit by a 1/1 sash window, as is the north gable end. The other windows contain 6/6 sash. Several doors displaying three long, narrow panels each date from the late 19th century. A screened porch crosses the front, or west facade.


