C. 1900

This two-story frame farmhouse faces north. It stands five bays long by one bay deep. Brick stove flues heat the center and the west end of the dwelling. Several modern sheds stand to the east of the house.

The west end of the house features two 6/6 sash windows, upstairs and down. A seam to the east of this section indicates that it was an addition. The eastern section is asymmetrically fenestrated. To the east end, one window on the second floor appears above one on the first floor. The west end of the east section includes a door to the east and a window to the west. A second floor window is positioned between these two features.


