This frame house is made up of a group of one story two bay by one bay components with steeply pitched gable roofs. Attached to the rear wall of the front section is a one story module of similar proportions with its roof ridge running parallel to that of the front section. At the rear of the house is a third module running perpendicular to the first two. The entire building is covered with asbestos shingle siding. Windows have six over six pane sashes.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house is made up of a group of two bay by one bay components with steeply pitched gable roofs. The front or west elevation consists of two bays and is one story in height. Attached to the rear wall of this section is a one story module of similar proportions with its roof ridge running parallel to that of the front section. At the rear of the house is a third module running perpendicular to the first two. There are also one story shed extensions to the north and south elevations.

The entire building is covered with asbestos shingle siding. Windows have six over six pane sashes. The main entrance is located in the south bay of the front or west elevation. Exterior brick chimneys are located at the north gable end of the front section, against the east end wall and at the south shed extension.

Behind the house is a large frame tobacco barn.


