This two-story frame house measures three bays wide by one bay deep. A prominent cross-gable distinguishes the facade. The gable-roofed house includes a front porch and a rear kitchen. 2/2 sash windows light the dwelling.

The structure is covered with asbestos shingle siding. Across the front is a former hipped roof porch which has been enclosed and is now part of the house itself. Centered in the cross gable is an arched top window. Brick chimneys are located inside the gable ends.


