DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two-story frame house measures three bays wide by one bay deep. A prominent cross-gable distinguishes the facade. The gable-roofed house includes a front porch and a rear kitchen. 2/2 sash windows light the dwelling.

The structure is covered with narrow guage wooden siding. A hipped roof porch which has been partially enclosed extends across the front elevation, obscuring a view of the main entrance. A similar porch extends along part of the north side. In the gables of the main section of the house are small gothic windows with pointed tops. A brick chimney is located inside the south gable end and a second is located in the ell.


